Conditions of Rental, unless otherwise agreed in writing

- Hirer must be a fully paid up GSC club member.
- Boats are generally only available for rent for an initial period of 6 weeks, with an option for a further 6 week period. This is to allow an equitable sharing of boats amongst Club members.
- The boat can only be used at GSC sanctioned events (i.e. it can not be taken away from the club for personal use or to participate at other clubs or association events, unless agreed in advance by GSC).
- The boat is only available for use on days that GSC has scheduled activities (usually Sundays).
- Occasionally the boat may be required to be used on Sunday mornings up until 12 noon for other Club activities.
- GSC can not guarantee availability of an alternative boat if the rented boat has been damaged or otherwise becomes unfit for use.
- Breach of any condition entitles GSC to terminate this agreement without notice

Renter is responsible for:

- rigging / de-rigging; washing of boat, rig and sails; ensuring all equipment kept together and correctly stored in the club rack after use.
- identifying to a Club representative any breakages or problems.
- payment for any damage to boat (other than wear & tear) up to the \$250 insurance excess.
- Ensuring all users of the boat always wear an approved Personal Floatation Device (PFD) when on the water.

GSC is responsible for:

- maintenance and any repairs to the boat
- insurance of the boat
- providing storage

INDEMNITY: To be completed by adult applicant.

I acknowledge that the Greenwich Sailing Club Inc (GSC), its officers, management committee, race officials, voluntary workers, and members shall not be held liable for any death, personal injury, loss or damage to property howsoever arising and therefore by signing the Dinghy Rental Form, I hereby release, to the full extent permitted by state, law and equity, GSC, its officers, management committee, race officials, voluntary workers, and members from all actual and contingent liability in respect of any personal injury, death, loss or damage to any parties or property.

I declare all persons using the GSC rental dinghy are able to swim at least 50 metres unassisted and are capable of taking care of themselves whilst ashore or on water under normal circumstances. I understand that they must wear an approved buoyancy jacket and I accept full responsibility for their safety whilst sailing.
